- \$750.00 per Yacht to register with Department of Inland Revenue (DIR) for VAT & TIN.
- \$500.00 per Charter for VAT filings for Yachts under 30 meters (up to 6 charters per quarter with no further charges for additional charters).
- \$750.00 per Charter for VAT filing for Yachts over 30 meters (up to 6 charters per quarter with no further charges for additional charters).
- VAT Payments will be made directly from the Yacht Manager to DIR's Bank Account by Wire Transfer. Windermere will provide details.
